The persons herein named are summoned to appear before a Public Inquiry convened under the auspices of this Tribunal and International Law on Monday, the Sixteenth Day of September in the year 2019 at 10:00 am in the City of Vancouver, Canada at a public location to be designated.

The persons herein named and duly served are formally charged by this Tribunal with planning, engaging in, concealing and aiding and abetting Crimes against Humanity and Genocide in Canada and other offenses specified and named in the Tribunal's Public Indictment.

**BE ADVISED** that as a recognized Tribunal of Conscience this Inquiry has the lawful power to convene a Common Law Court of Record to prosecute and sentence the persons herein named, depending on the findings and recommendations of the Tribunal's judges. Any refusal or failure to respond to this SUMMONS may result in a guilty judgement against the accused.

The proceedings of this Tribunal and Common Law Court will operate under the oversight and with the participation of the ITCCS Directorate and its legal advisors, and international human rights and diplomatic observers. The presence of United Nations Peacekeepers at this Tribunal has been requested. Its proceedings will be open to the public and the world media.

THEREFORE, the charges and specifications in this INDICTMENT and the evidence upon which they are based warrant the immediate issuing of the accompanying PUBLIC SUMMONS to the individual persons therein named and the convening of a Public Inquiry by the International Tribunal of Crimes of Church and State in the City of Vancouver on the Sixteenth Day of September in the year 2019.

This INDICTMENT is issued on the Seventh Day of June in the year 2019 and is filed and registered at the United Nations and within duly constituted Common Law Courts of Record within Canada.

# **A Public Indictment of the Crime of Genocide in Canada**

## **INDICTMENT**

### **Count One**

#### **The Tribunal charges:**

That the Government of Canada, the Privy Council Office and the Crown of England through the Governor-General, and the Vatican and the Roman Catholic Church, the Church of England and the United Church of Canada, as part of a joint, deliberate and ongoing Criminal Conspiracy, have willfully planned, committed, concealed and aided and abetted the following crimes:



1. The intentional Genocide of Indigenous and other non-Christian peoples and their children as part of a calculated war of extermination,
2. The imprisoning, harming, trafficking, exploiting, torturing and ritual killing of those children and others under their legal care and custody,
3. The violent occupying and exploiting of the lands and resources of Indigenous and other non-Christian peoples,
4. The financial defrauding of the people of Canada by falsely posing as legitimate religious bodies in order to avoid taxation, and
5. The active concealing of these and other offenses and the deliberate obstructing of justice.

## **Count Two**

### **The Tribunal charges:**

That the Government of Canada, the Privy Council Office and the Crown of England through the Governor-General are continuing to plan, commit, conceal and aid and abet these offenses with their Church partners in Genocide by offering political and legal protection to all of those Church Corporations, including tax exempt status under Canadian law, special protective privileges under the Criminal Code of Canada, and diplomatic recognition and immunity from prosecution for these and other offenses; by assisting these Church Corporations to obstruct, evade and deny justice; by publicly dissembling, burying and distorting the truth of this ongoing Genocide; and by other crimes to be elaborated in the Tribunal proceedings.

### **Count Three**

#### **The Tribunal charges:**

That the Government of Canada, the Privy Council Office and the Crown of England through the Governor-General are also partnering with and aiding and abetting similar crimes by the government of China and its corporations operating within Canada: specifically, the genocide of indigenous peoples, the theft and exploitation of their lands and resources, the trafficking, ritual torture and murder of indigenous and other men, women and children, the infiltration and subversion of Canadian courts and government bodies, and the concealing of these crimes and the obstructing of justice.

### **Count Four**

#### **The Tribunal charges:**

That as a result of these offenses and Criminal Conspiracy, the said Church Corporations and the Government of Canada, the Government of China and its Corporations and the individual persons named in our PUBLIC SUMMONS constitute a real, present and ongoing threat and danger to the lives, safety, wellbeing, sovereignty and liberty of all Canadians and their children; and that therefore under International Law these individual persons and their corporate institutions constitute rogue criminal powers that have lost their authority and right to operate within Canada or to lawfully govern.

This SUMMONS is issued on the Seventh Day of June in the year 2019 under

The International Tribunal of Crimes of Church and State (ITCCS).
